ANNUAL MEETING

The Annual Meeting of the AFLA convened at 11:30 A.M., June 19th at the Neighborhood Club in Grosse Pointe. President Miguel de Capriles reviewed the problems of financing rotation of the National championships to cities other than New York or surrounding areas. The members then heard discussion of the problem as faced by the Midwest Section and the Michigan Division.

The two constitutional amendments (reported in the last issue of American Fencing) were discussed and put to a vote. The Office of Foreign Secretary was made elective by unanimous consent. The proposed amendment to the present definition of an amateur fencer was defeated by a vote of 102 to 14.

The officers elected for the 1951-52 season are: Miguel A. de Capriles, President; Scott D. Breckinridge, Jr., Vice-President; Salvatore Giambra, 2nd Vice-President; Captain Richard C. Steere, USN, 3rd Vice-President; Dernel Every, Secretary; Robert S. Driscoll, Treasurer. The office of 4th Vice-President was left vacant through an oversight by the nominating committee and will be filled by appointment of the Board of Governors.

The Nominating Committee to propose candidates for office in 1952-53 was selected and consists of the following: Dr. James Flynn, Chairman, Miss Helena Mayer, Scott Breckinridge, Jr., Hal Lattimore, Norman Lewis.

The meeting then heard reports of divisional activities from: Donald Thompson, Illinois; Albert Wolff, Kentucky; Paul Utterback, Maryland; Mrs. Jean Rinaldo, Miami Valley; Howard Hayden, Michigan; Dr. James Flynn, New Jersey; Gerard Biagini, Northern California; Donald S. Thompson, Northern Ohio; Dr. Paul Makler, Philadelphia; Sewell Shurtz, Southern California.

Non-Divisional Meeting

The Annual Non-Divisional Meeting was held at the Fencers Club on June 7th, and the following were elected to the Board of Governors: Pat Benson, Saltus-McBurney; Warren Dow, New York A.C.; Dorothy Friedman, Salle Santelli; Paul Gallico, Fencers Club; Jack Gorlin, Salle Santelli; Nathaniel Lubell, Fencers Club; Dr. Paul Moss, Salle Santelli; Albert Vogt, New York A.C.; George Worth, Salle Santelli. These governors take their seats at the first meeting of the Board for the 1951-52 season.

A Nominating Committee for non-divisional governors to take office for 1952-53 was also chosen, and consists of the following: Dernel Every, NYAC; Helena Dow, Fencers Club; Norman Lewis, Salle Santelli; Frank McGrath, Saltus Club; Robert Zaum, Mercado. There was general discussion of non-divisional affairs and it was proposed that a new effort be made to improve officiating by conducting a judging school. Mr. Dow, who has considerable experience in this field, offered to direct the activity if it were properly organized.

THOSE ELECTRIC EPEES

Despite repeated warnings, a very large percentage of the epees at the Nationals failed to meet the minimum standards fixed for competition. The committee relaxed some of its rules in order to permit almost one half of the entries to compete in the championships, but this mercy ought not to be extended much longer. The weapons were either illegal or not in proper working order, and the worst part of it is that many of them had been purchased for the express purpose of competing in Detroit. Fencers have a justifiable complaint against any dealer or coach who sells them weapons which do not conform to regulations or are assembled so badly that they will not function properly. The other major source of trouble is the failure to take care of the weapons between competitions.

It would be incredible that a shooter would enter the Nationals with a gun that was rusty and the sights unadjusted; that an archer would compete with a make-shift bow and arrows that had lost their feathers! yet this is exactly what fencers are doing when they travel to a championship and do not have every piece of their equipment thoroughly tested and adjusted BEFORE they leave.

Next year is Olympic year and we know that the international committee very properly makes no exceptions or modifications of the rules. Our Olympic men must accustom themselves to weapons which are absolutely right, and it behooves all committees next year to enforce the specifications from the very beginning. The manufacturers and dealers will provide proper equipment if you insist on its being perfect. If your weapon breaks down, have it repaired right after the competition instead of waiting until just before the next one.

FAMILY SPORT?

The Nationals this year threw the spotlight on the increasingly large number of families competing in our most important event. There were four husband-wife entries: Dr. Paul Makler and Hope Makler (Philadelphia); Harold and Penny Newton (Washington, D. C.); Donald and Sue Thompson (Illinois); Sidney and Roslyn Schwartz (Buffalo). As far as we know this is the largest number of such entries ever had in Nationals. Abram Cohen and his sister Eve, both from New York, also competed. The most interesting of all, however, were the family entries in the same event. The epee saw Donald S. Thompson (No. Ohio) and his son Donald (Illinois) renew their rivalry of last year and Dr. Franklin Jones competed in the same event with his son Roger (Philadelphia). The sabre pitted the Gorlin brothers, Jack and Sol (New York) against each other.

The husband-wife entries recall such great pairs as Harold and Evelyn Van-Buskirk, Leon and Florence Schoonmaker, Warren and Helena Dow. The brothers and sisters recall Nick and Arthur Murray, Warren and Eddie Dow, Miguel and Jose de Capriles, Samuel and Mildred Stewart.

Bout Committee's View

Once again the large entry lists reflected the growth of fencing. There were 37 teams and 162 individuals representing clubs from all parts of the country.

The Bout Committee decided to make the individual events provide the maximum competition, with a final of nine or ten in each championship. This was done for two reasons: (1) Next year is Olympic year and it is desirable to subject possible contenders to strenuous competition; (2) It gave the top men from the divisions as much opportunity as possible to fence against the strong field and thus raise their own standard of fencing.

The facilities at the Neighborhood Club in Grosse Pointe were very good and the fact we could run nine strips at the same time enabled us to hold two of the largest events on the same day. The selection of Detroit as the site for the Championships encouraged large entries from the Midwest section yet did not deprive the individual events of top-caliber fencers from the other major centers. Mr. Howard Hayden and Mr. Byron Krieger, and their committees, deserve much credit for the arrangements and the better-than-average advance publicity. Unfortunately the Neighborhood Club was too far from the center of Detroit to encourage the large audience we might otherwise have had.

The week-long tournament could not have run so smoothly without the help of many and the understanding of all. We are deeply grateful to the contestants for their sportsmanship and self-discipline. Mistakes were unquestionably made, but bad breaks were taken in good grace. We also wish to thank especially our friends of the Neighborhood Club, Gerard Biagini and Byron Krieger for their yeoman work as directors, Richard Perry and his charming young girls who kept the score-sheets and score-boards, the many fencers who judged, and finally Miguel de Capriles who worked from morning till night every day without let-up and without whose help and advice our task would have been impossible.

SHAME!

It has come to my attention that Mrs. Theota Bridges who entered the Nationals from Troy, N. Y. returned to her home town in Ohio and received much publicity on the basis that she had finished high in the Championships and was ready to train for a berth on the Olympic Team. The true facts are that she was admitted to the Championships by courtesy of the Board because she lived where she could not compete in a qualifying round. At Detroit she was eliminated in the first round without having won a single bout and it was very apparent that she could not have qualified for the Nationals from any Division having capable girl fencers.

Perhaps the reporter was too enthusiastic, but certainly the basic facts must have been furnished to him. This type of self-serving and inaccurate publicity does the sport no good and, when exposed, can lose us the good will of the press.



PIETER MIJER

We have always pointed with pride to the fact that fencing is a sport which can be enjoyed for many years after a man has finished his school days. But even in our wildest claims we have never approached the accomplishment of the nation's oldest competitor, Mr. Pieter Mijer. Mr. Mijer, in his 70th year, placed second in the All-Eastern Open Epee Championship and then qualified for the Nationals in Detroit where he competed in both the team and individual championships. In the team event he spark-plugged the Salle Santelli team with an impressive number of victories.

Men ten and twenty years younger than Pieter, still able to participate in an active sport or to compete in local club competition, are remarkable indeed; but to qualify for and place high in an open championship at an age when most men are on the side lines glorifying in the past, is probably without parallel in the annals of all sport.

Pieter Mijer learned to fence at the age of ten in Schiedam, Holland. He came to this country after the first War and won the junior epee crown in 1923. He was National Outdoor Champion in 1927 and represented Holland on its 1928 and 1932 Olympic teams. He won the Veterans 3-Weapon Championship and has been a member of five national championship teams. He was one of the founders of the Washington Square Fencers Club which for many years flourished in the Metropolitan area and now represents the Salle Santelli. Few men have given so much of themselves to the sport either as competitors or as devoted supporters.

Mr. Mijer is a textile designer of great reputation and is an outstanding authority on batik work. He is an extremely versatile artist and can usually be found at his studio in Greenwich Village when not on the fencing strips.

THE 1951 NATIONAL CHAMPIONSHIPS

On the whole, the 1951 National Championship Tournament, held in Detroit, was an outstanding fencing (though not a financial) success. The individual championships were well attended by all sections of the country, and the number of actual contestants compared favorably with previous years. We also had a record entry in the women's foil team event; but the quality of the men's team events was below par largely because of the absence of established stars from the major New York clubs who made the trip to Detroit only for the individuals.

All of the competitions were held at the Neighborhood Club, in Grosse Pointe. The facilities were adequate and the organization excellent. Unfortunately, despite the efforts of the local committees, the attendance by the public was not what had been expected. Only the women's event and the sabre individual drew a sizeable crowd, and those who came as spectators were mostly fencers. The problem of financing our national championships by gate receipts remains unsolved.

As in recent years, the girls from Southern California dominated both the team and the individual women's events, but the Eastern fencers overpowered the opposition in the men's competitions. On the matter of successful title defenses, this year was the opposite of last year: The three 1950 individual champions who made an appearance retained their crowns, but only two of the four team champions repeated.

Among the clubs, the Fencers Club had the best score with two team titles (foil and epee) and one individual (epee); second places in the women's team, men's individual foil, epee and sabre; and third places in the sabre team and men's individual foil. The New York Athletic Club batted 1,000 in the team events, capturing the only two it entered (sabre and three-weapon), and also took one individual first (foil), but no other places. The Faulkner School of Fencing retained its team crown and also won third place in the women's individual. Salle Santelli was shut out of the team titles for the first time in many years, but retained the individual sabre championship, placed second in the sabre team, and third in the epee and three-weapon teams. The Michigan Division, entering teams in a national championship for the first time, made a fine record: second places in the foil, epee and three-weapon teams; and third place in the women's team.

Among the individuals, Janice Lee York, Silvio Giolito and Tibor Nyilas deserve all the credit that goes to champions who successfully defend their crowns. Each of them fenced in only one event and came through. Jose de Capriles took time out from his duties as national bout committee chairman, not only to win the vacant epee title but also to spark plug the Fencers Club teams in epee and sabre. Byron Krieger repeated his "iron man" role of the Pan American Games and fenced in all the men's events except the epee individual, finishing high in both foil and sabre. He, more than any-

one else, was responsible for Michigan's excellent record in the tournament. Dr. Paul Makler and Allan Kwartler showed the greatest improvement in the past year, and both made two of the individual finals. On the other hand, the two leading young men from the Pacific Coast, Jerry Biagini and Sewall Shurtz, were the greatest disappointments, perhaps because we had come to expect too much from them too soon.

This year, all of the championships were fenced through to a conclusion in a single day, and there was no formal Gala Night. However, the social touch which is so characteristic of fencing all over the world was maintained through the hospitality of the Salle de Tuscan. Not only was its charming clubhouse open for post-mortems and relaxation after every event, but on the final night all the fencers were invited to a beautiful garden party which included gypsy music, dancing, singing, and refreshments.



FOIL TEAM CHAMPIONSHIP A.F.L.A. Trophy

Won by Fencers Club (N. Y.)

The opening event of the 1951 tournament resulted in the first successful title defense, when the Fencers Club (N.Y.) conquered its only serious rival, the Michigan "A" team, 6-2, in the foil team championship. The field of four was disappointingly small, and the other two teams in the competition, Michigan "B" and Wisconsin, were completely outclassed.

EPEE TEAM CHAMPIONSHIP

J. Sanford Saltus Trophy

Won by Fencers Club (N.Y.)

Salle Santelli's four-year winning streak in the epee team championship came to an end as the favored Fencers Club (N.Y.) combination, after a wobbly start, swept its last four matches to win its second 1951 title in two days. The new champions barely squeezed past New Jersey, 5-4, in the qualifying round, and then suffered a humiliating 6-3 defeat at the hands of three cocky youngsters from Texas A. & M. in the first match of the six-team round-robin final. At this point, the Fencers Club called upon its most reliable epeeist, Jose de Capriles, to rally its disorganized forces, and the maneuver proved to be a winning one. Michigan's "A" team, victor over its "B" squad by 9-0, captured the runner-up spot on bout victories over Salle Santelli and Kentucky. The defending champions, who finished third, sorely missed their great star, Norman Lewis, but still might have won or tied for first if they had not made tactical errors in their choice of competitors for the last two matches. Kentucky fought hard for an upset, and its final match with the Fencers Club was the decisive battle for either the championship or fourth place, so closely bunched were the first four teams. The rampant Texas Aggies eliminated one of the top-seeded teams, Chicago's University Club, to reach the finals in their first major competition, and then scored their astounding victory over the new champions; but the fire of youth eventually yielded to technique and experience, and the Aggies did not win another match.

Jose de Capriles, representing the Fencers Club, became the first individual champion of 1951 when he regained the epee title he had last won in 1938. Jose has been a top-flight epeeist since his college days but he has seldom turned in a better performance in the past 18 years than he did in Detroit, despite his comparative inactivity during this season. Last year, Jose was shut out of the final when he suffered three semi-final losses after winning 12 consecutive bouts; this year, he also lost three bouts, but only one in each of the three rounds of competition, and he was unbeatable in the clutches. Although the three medalists of the past two years were absent, the quality of the fencing was very good, and the results ran true to form as the first four places went to seasoned veterans. Al Skrobisch of the Fencers Club, who reached the final undefeated, was second; Albert Wolff of Kentucky, 1946 champion, took third; and Jim Strauch of the Fencers Club, 1947 titleholder, finished fourth on a count of touches. Walter Hauber of New Jersey suffered the heartbreaking experience of missing the final by a margin of two touches despite his five victories in the difficult semi-final round.

FOIL INDIVIDUAL CHAMPIONSHIP

John Allaire Memorial Trophy

Silvio Giolito's successful defense of his foil championship was the most brilliant individual performance of the 1951 nationals, as the New York A.C. star went through undefeated in the entire competition. In fact, only two former national titleholders, Daniel Bukantz (1949) and Nat Lubell (1948) both of the Fencers Club, carried him to 5-4. The last bout of the competition, between Giolito and Bukantz, was a fitting climax to the event, as the two powerful left-handers, each with 7 victories in the final, swapped touch for touch to the bitter end. Lubell suffered three defeats, all by 5-4 scores, but took the third-place medal by a margin of five touches over Byron Krieger of the Salle de Tuscan, Detroit. Neil Lazar of Salle Santelli, Dr. Leo Kellerman of the Fencers Club, and Al Kwartler of Santelli, all showed improvement over their previous performances. Dernel Every of the New York A. C. tired badly toward the end. The ninth finalist, Don Thompson of Illinois, was outclassed in foil, but his surprise qualification made up to some extent for his failure to make the final in his favorite weapon, the epee.

**SABRE INDIVIDUAL CHAMPIONSHIP

Dr. Tibor Nyilas of the Salle Santelli, Pan American sabre champion, retained his U. S. title by defeating the veteran Norman C. Armitage of the Fencers Club in the last bout of the 1951 national championships. Armitage needed to win in order to tie Nyilas and force a fence-off; but the defending champion, capitalizing on his superb timing to the utmost, reeled off a 5-1 victory for a clean sweep of his nine final bouts. Sol Gorlin of Salle Santelli, showing a remarkable improvement during the past year, earned the bronze medal by a one-touch margin over his famous team-mate, George Worth, who again had to be content with fourth place. ALL-EASTERN CHAMPIONSHIPS

This year the All-Eastern Open Championships replaced the Metropolitan Championships which had been held heretofore and produced some very interesting competitions. Not one of last year's Metropolitan champions was able to win the All-Eastern title.

Dr. Daniel Bukantz, Fencers Club, won the foil event from a strong field of twenty, going through twelve bouts with only one defeat. Second place went to Capt. Richard Steere, USN, representing the Baltimore F. C. Steere made an impressive return to major competition after an absence of some years. The epee title was won by Alfred Skrobisch of the Fencers Club with only one defeat in the final nine. A complete tie for second was fenced-off between Pieter Mijer and Dr. Paul Moss, both of the Salle Santelli, with Mijer winning 3-2. Isaac Sanders and James Strauch of the Fencers Club were also tied with Mijer and Moss on bouts, but dropped out of the fence-off on account of touches. Metropolitan Champion, Jose de Capriles, was eliminated in the first round. Seventeen competed.

George Worth of the Salle Santelli defeated his teammate Jack Gorlin in a fence-off 5-4 at the end of an 11-man round-robin. Third place went to Metropolitan and National Champion Dr. Nyilas. Sol Gorlin, Salle Santelli, placed fourth while Abram Cohen, Fencers Club, nosed out Dr. James Flynn, NYAC, for fifth on touches.

N.C.A.A. CHAMPIONSHIPS


Thirty-four colleges competed in the 1951 event held at the University of Illinois on March 30th and 31st. Each college was represented by not more than one individual in each weapon and complete round-robins in foil, epee and sabre produced the individual champions and gave a basis for awarding the team title. There were 28 men in the foil and epee pools and 29 in the sabre.


The team title was won by Columbia with a total of 69 victories, having won the foil and epee pools and placed second in the sabre. Pennsylvania placed second with 64 victories and Navy was third with 61.

Chambless Johnston of Princeton was the only individual champion to win his crown without a fence-off. He took the sabre title with a 25-3 record which was two victories more than his nearest rival. John Krajcir of Columbia placed second on touches over Frank Bartone of Pennsylvania and Carl Knobloch of Yale who placed in the order named.


Robert Nielson of Columbia was the only champion to defend his title successfully. He retained the foil crown after a three-way tie with Gerard Biagini of San Francisco State and Harold Goldsmith of C.C.N.Y. Nielson defeated his two rivals 5-4 in the fence-off and then Biagini turned back Goldsmith 5-4 for second place.

The epee title was won by Daniel Chafetz of Columbia in a fence-off with William Thomas of N.Y.U., after both men had finished the regular round-robin with a 22-5 record. Third place went to Leonard Atkin of Illinois on touches over Stanley Harms of Pennsylvania.
