JAMES M. CASTELLO by Jeffrey R. Tishman

James M. Castello, the assistant fencing coach at New York University for twenty-nine years ending last season, died on October 25th, after a long illness. He was 58 years old.

"Jimmy" was the son of Julio Martinez Castello, the 1924 U.S. Olympic Coach, and New York University's first fencing coach; and the brother of Hugo M. Castello, the University's second fencing coach. Jim had been assistant coach to his father and brother from 1945 until last season, when he retired for reasons of health.

A graduate of N.Y.U.'s school of Education in 1939, he was a member of the Intercollegiate Championship Sabre Team of that year. During World War II, he worked with the Sperry Corporation in a prototype development capacity.

Jim's favorite interest in fencing centered on the armorer's craft. In his work at Castello Fencing Equipment and as an armorer for the Metropolitan Division during the 1940's and '50's he was responsible for many innovations in the development of the electric foil. For his expertise in all areas of this work, he was named armorer of the 1959 Pan American Team.

When he moved his family from New York City to suburban Long Island in the 1950's, his enthusiasm for our sport led him to help establish the Long Island Divi-

THE MARINE CORPS FENCING PROGRAM

by Capt. Jeff Kestler

In February 1974 at Quantico, Virginia, the Marine Corps formed a fencing team under the auspices of Major Ken Jordan, the Marine Athletics Officer. Five months later at the National Championships in New York the same team won the United States Foil Team title by defeating the New York Athletic Club 8-1 and the New York Fencers Club 5-4. It is the purpose of this article to describe briefly the method by which this result was attained in the hope that it may be some value to others in planning their training programs.

We were fortunate to have three experienced fencers to start with: 2nd Lt. Ed Donofrio, Captain Jeff Kestler, and 1st Lt. Bert Freeman were collegiate all Americans and the latter was a former National Champion and Olympian. We determined at the outset that our entire training program would have a two-pronged approach: physical conditioning with emphasis on flexible fencing technique. To serve the first end we established a daily program of calisthenics and cross country running. Each practice began with a half hour to forty five minutes of traditional warm up exercises: jumping jacks, bend and reach, trunk twisters etc., and ended three to four hours later with a three mile run during which all hills were sprinted to develop power. As we increased the duration of our actual fencing workouts, we found that it was no longer possible to run after practice. so at the beginning of May we increased the length of the runs to five miles but held them in the morning when we were fresh. We soon discovered that even with a recovery period of a couple of hours the runs were taking a good deal of the elasticity out of our legs so that our fencing in the afternoon was somewhat lethargic. We cut the runs to four miles and this seemed to do the trick.

After the initial warm-up phase of our training day we utilized an exercise which combined wind sprints with some basic fencing footwork. From the on-guard po-

sition each fencer would execute a rapid fleche and continue sprinting for twenty five yards, at which point he would assume the on guard position and execute a rapid series of retreats to the starting line. The exercise was repeated ten times with a two minute rest followed by another ten repetitions. At this point fifteen minutes of individual fencing stretching and warmup exercises prepared us for the "lesson" phase of our workouts.

We did not have a fencing master. Initially, we took advantage of a kind offer of help from Coaches Andre Deladrier and Steve Bujnovsky of the Naval Academy, but time pressure and the energy crisis put a guick end to this. Necessity is the mother of invention and we all became fencing masters and attempted to pool our knowledge into workable lessons. Returning to our concept of physical fitness, we decided that lessons would consist in large part of lunges and advance lunges and would last until the "pupil" could not physically continue. An important element was included in our lessons to develop flexible techniques. During the last five or ten minutes of the lesson, the "master" would perform a combination of unprogrammed movements which required spontaneous non-mechanical responses from the pupil and often called for him to alter his attack in the middle of an advance lunge. For example, the "master" would move his weapon back and forth between the four and six lines, and the "pupil" would commence a one-two attack at which point the "master" might execute a single or double counter parry. In order to hit, the "pupil" would have to deceive whatever was thrown at him in the midst of his attack. He had to be flexibleto be able to expect and respond to the unexpected. This procedure was difficult and frustrating but proved more valuable than executing an established series of exercises.

While "pupil" and "master" were engaged in the lesson, the third member of the team would watch the 'pupil's" performance and offer frequent criticism. Our emphasis was on improving the very building blocks of our fencing. The first month

of our training spent literally relearning the lunge. We forced one another to extend the arm first snap the back leg, improve balance etc., and regardless of our experience, we realized that we had a great deal to learn.

After each of us had received a lesson of approximately thirty to forty minutes, we entered a period of controlled bouting exercises. The first exercise consisted of a round robin in which touches could only be scored by straight attack or straight parry riposte, i.e. no feints or taking of the blade could precede the attack or the riposte. This forced each fencer to concentrate on distance and timing. The next series of controlled bouts placed each fencer alternately in the position of attacker or defender. A defender could only score by riposte or stop thrust while in the next bout as attacker he could work on his offensive game. Finally, we finished our session with thirty minutes of round robin fencing.

This routine was followed every day and was rarely changed. Perhaps the most important part of the program described above was that we entered every competition in foil and epee that we could, and hence, he sixth day of a typical week consisted of a competition. During the course of these competitions, we had occasion to evaluate ourselves and our opponents. On Mondays we would hold discussion which consisted of an analysis of significant flaws that we had observed in our own fencing and in suggestions for successful techniques to use against particular opponents. This type of session proved extremely worthwhile.

Looking back on our program with insights gained at the National and World Championships we realize that it constituted only a first step towards improving our fencing, but it was a firm step.

NEW REGULATION ON "SIMULTANEOUS ATTACKS" IN SABRE

(Ed. Note: On 17 May 1974 the FIE Congress at Monte-Carlo voted to try out new rules for judging in sabre, designed to reduce or avoid simultaneous attacks. These rules were to be applied, and were applied, at the World Championships at Grenoble in July. As they have not yet been designated with article numbers, so far as we have heard, they are not yet a permanent part of the rule book; rather, they should be regarded for the present as an ad hoc experiment, likely to be used in FIE events, and optional at lower levels. The full text follows:)

After two consecutive "simultaneous attack" decisions (i.e., one right after another) in the course of a bout, the Director will issue a warning to both fencers, this warning to remain in effect even after the exchange of one or more valid or invalid touches.

- If, after this warning, there is another decision of "simultaneous attack," the bout will be resumed under the following conditions:
- the two fencers will in turn be given the benefit of the initiative or priority to attack; the fencer not so benefited is prohibited from causing a "simultaneous attack" decision, on penalty of being declared touched, unless on that action he succeeds in touching his opponent on valid or invalid surface, Without himself being touched.
- the selection of the first attacker, that is, of the fencer who will first be given the benefit of this initiative on the attack, is decided by drawing lots, supervised by the Director.
- after the first exchange that produces a valid touch, the roles of the fencers are reversed: the fencer who had first benefited from the initiative on the attack now being prohibited from causing a "simultaneous attack," on penalty of being declared touched.
- in case an invalid touch or no decision results from an enchange, the fencer who had the initiative on the attack retains it when put back on guard.

— after the second exchange that produces a valid touch, the bout resumes in normal fashion. However, in case there are two new consecutive "simultaneous attack" decisions, the Director, after warning both fencers, will, every such time, apply the preceding regulations.

For the application of this rule, "simultaneous attacks" in which:

- each fencer is touched on valid or on invalid surface,
- one fencer is touched on valid surface and the other on invalid,
- neither fencer is touched (in this case the Director must not take into consideration any action following the simultaneous attack that produced no result).

must be counted in calculating the required two consecutive decisions.

On the other hand, a decision of "simultaneous attack" in which only one fencer is touched, either on valid or invalid surface, will not be used in the calculation.

Scoring the Bout

If the score of the bout is 4-3, 4-2, or 4-1 at the time the lots are drawn, each fencer must still benefit in turn from the attacking initiative, even if the score becomes 5-3, 5-2, or 5-1 by the first valid touch following the drawing of lots.

If the application of the rule brings the final score to 6-3, 6-2, or 6-1, the bout is halted and the winning score entered on the score sheet for the pool will be 5-3, 5-2, or 5-1, as though this were the actual score.

When the score is four-all, the rule will likewise be applied, in turn, for each fencer:

- if the application of this rule brings the score to 6-4, the bout is halted, and the winning score entered on the score sheet for the pool will be 5-4.
- if the application of this rule brings the score to 5-5, the bout will be resumed in normal fashion to determine the final touch. However, if in the continuation of

the bout three new "simultaneonus attack" decisions again oblige the Director to determine the offensive initiative by lot, the first valid touch scored will end the bout and the winning score entered on the score sheet of the pool will be 5-4.

 - 1. In the official FIE competitions. pool of four will be fenced on a single strip and the order of bouts will be as follows:
 - -1st bout: 1-4
 - -2nd bout: 2-3

Three minutes rest (see 526).

-3rd bout: the winner of the first bout against the loser of the second. -4th bout: the winner of the second bout against the loser of the first. Three minutes rest (see 526).

If at the end of the first four bouts only one of the four fencers has two victories, his third bout will be fenced before the remaining one.

The foregoing is the complete text of changes to the numbered articles of the rule book, as adopted by the FIE in May 1974 and officially reported to date.

(Note: The change in Article 577 means that the No. 1 and No. 2 teams as determined by the fencing will toss for the top and bottom half positions on the tableau for direct elimination and will no longer go automatically No. 1 to the top and No. 2 to the bottom. The same applies to the remaining pairs, 3 and 4, 5 and

Weapons Check: Weapons check is 45 minutes before each starting time.

Qualification: Each division is entitled to a minimum of two qualifiers per weapon, excluding automatic qualifers. If there are 12 to 20 fencers in the qualifying tournament, 3 qualify; if 21 to 30, 4 qualify; if 30 or more, 5 qualify. The finalists of the 1974 U-19 Nationals and the U-20 championships automatically qualify if they still meet the age requirements. Each division is entitled to 2 qualifiers in the U-16 event per weapon, excluding automatic qualifiers. Finalists in the 1974 U-16 event qualify automatically if they still meet the age requirements.

Certification: Immediately upon the completion of the qualifying competition in each weapon the Division Secretary must transmit to Colleen Olney, 2221 SE 117th, Portland, OR. 97216, the following information:

- 1. The number of eligible fencers taking part in the qualifying competition.
- 2. The names of the qualifiers including the automatics in order of their placing in the qualifying competion.
- 3. The names of alternates in each weapon.

This information must be received by February 1, 1975.

A competitor may enter all events for which he is qualified. In case two or more events are run concurrently, the fencer must bear the burden of fencing bouts in each weapon in rapid order when called.

Entry Fee: \$5.00 per each weapon entered.

Registration Fee: \$2.00 for all.

PROCEDURE FOR ENTRY TO NATIONALS WITHOUT COMPETING IN QUALIFYING EVENT

At its meeting in September 1974, the National Board of Directors reinterpreted the Operations Manual and established guidelines for appeals by fencers who cannot qualify through local qualifying events. The guidelines are as follows:

- 1. Appeals may be filed by fencers who were qualifiers (by means of competition or appeal) or alternates in the prior season and either were unable to compete in local qualifying events this season or did compete and had to withdraw because of a disabling injury or illness.
- 2. All appeals must be received by the National Secretary by the deadline for entry in the Nationals and must be accompanied by a \$5.00 filing fee.

- 3. All appeals must include sp tails as to the dates, reason for and other pertinent facts. Any reasons must be substantiated t confirmation from a doctor.
- 4. All appeals must be accomi a summary of the fencer's compe sults during the current season.
- 5. Appeals will be reviewed by tional Executive Committee. Deci be based on the validity of reason sence or withdrawal and the prot the fencer having qualified thro petition, based on results achieved events.

AMERICAN FENCING

A NEW NATIONAL CHAMPIONSHIP TROPHY by Jeffrey Tishman

At the 1932 U.S. Olympic Trials in New York City, a special sterling trophy was presented to Miguel de Capriles, the winner of the epee tryout, by the most successful national champion of the period, Leo G. Nunes.

Miguel de Capriles went on to make four Olympic Teams and become the President of both the Amateur Fencers League of America and the International Fencing Federation. Leo G. Nunes, whose eighteen national individual titles represent the alltime AFLA record, continued over the next four decades to contribute much to American fencing and in particular to the Junior Olympic Movement, until his death last June at the age of eighty-two.

In memory of Leo G. Nunes, Dr. Miguel de Capriles of New York University "redonated" the cup he won forty-two years ago to the AFLA as the trophy for the Under-19 National Epee Championship. The first re-

cipient of the new trophy is this year's champion Greg Massialas of the Fencing Academy of Michigan.

The new trophy is a sterling silver cup on a teak base. The cup bears the original inscription: "Epee Tournament: New York: February 1932: First Prize: Miguel A. de Capriles."

The base that the trophy stands on is fitted with a sterling collar, engraved on one side "Nunes Cup" and on the other "Under-19 National Epee Champion" with the legend "this trophy was awarded by Leo G. Nunes for the Olympic Tryout of 1932 and was donated in his memory to the AFLA in 1974 by Miguel A. de Capriles."

The Leo G. Nunes Trophy joins two other Under-19 National Championship Trophies in honoring significant figures on the American fencing scene. The Under-19 National Women's Foil Trophy first presented in 1970, honors the late Marion Lloyd Vince, the first American woman to reach the Olympic final round; and the Under-19 Men's Foil Trophy that was initiated in 1971 commemorates the late Rene Pinchart, a four-time U.S. Olympic Fencing Coach.




