Since the author was a member of the AFLA whose real name we knew, we advised him that we'd publish his article, but under his own name only. This was agreed to and done.

Recently we received a "letter to the editor" which was extremely critical (not constructive criticism) of the AFLA. The author, whose typewritten name was "Victor Janus", claimed to be "a fencer of considerable competitive experience and accomplishment, well known in the fencing fraternity and a noted professional in athletics".

The return address on the envelope was "General Delivery", Anaheim, California.

1976 OLYMPICS CAPSULE REPORT

The 1976 Olympics saw a number of dramatic upsets which, in my opinion, signalled some profound changes in international fencing. A junior Italian fresh from a Bronze medal in Poznan, won the Olympic Foil championship ahead of four experienced French and Soviet fencers. The German and Italian Foil teams ousted the French and Russians from their perennial spots to take the Gold and Silver medals, and even the British stepped into the top ranks by taking sixth.

In the saber events, the Hungarian decline of the past few years continued without a single representative in the individual final, and the Hungarian saber team was whipped by Romania 9-4 to fall out of the money to fourth place. Cuba's sabre team advanced to the fifth spot in world ranking, over Poland, while the U.S. squad again slipped down, out of the rankings. In Epee, Sweden, Germany, and Switzerland dominated, and in the Women's event the French women took over the Silver medal spot from the Socialist grip. This increasing competitive pressure on the Socialist countries will, I am sure, stimulate renewed efforts by them to regain their dominance of the past years. They have the wherewithall to do it, and we can expect the level of international competitive fencing to rise even higher.

The U.S. Olympic team gave another disappointing performance and, overall, did not perform as well as the 1975 World Championship team in Budapest. While the Foil and Sabre men did a little better individually, the Epee men and Women's team did much worse. The Foil and Epee teams were not able to demonstrate any improvement. The quick elimination of many of our competitors right in the first round showed that they were not properly prepared. American fencers must train more seriously if they are to merit participation in future international competition.

AMATEUR FENCERS LEAGUE OF AMERICA, INC. Annual Meeting

The 1976 Annual Meeting of the AFLA was held on July 2, 1976 at the Cherry Hill Inn in Cherry Hill, New Jersey. Stephen Sobel, President, called the meeting to order at 4:15 PM. Present were Irwin Bernstein, Secretary; Howard Goodman, Treasurer; approximately 20 members in person and 25 members by proxy.

A. Minutes of the Previous Meeting

The minutes of the June 24, 1975 meeting had previously been published in AMERICAN FENCING July/August 1975. The Secretary read excerpts from the minutes because of the continuing interest in some of the issues raised at that meeting. The minutes were then accepted as published.

B. OFFICERS REPORTS

A financial report for the 9 months ending April 30, 1976 having been submitted to the Board at its meeting on July 2, there were no officers reports at this meeting.

C. By-Laws

There were no amendments to the by-

D. Elections

E. Unfinished Business

There was no unfinished business.

F. New Business

There was no formal new business. In keeping with the practice of the past few years, the balance of the meeting was devoted to an informal discussion of matters of concern to the membership with the purpose of advising the officers and members

The 1976 Annual Meeting of the AFLA of the Board of Directors of these concerns while informing the members of current n in Cherry Hill, New Jersey. Stephen policies. Among the topics covered were:

- 1. National team championships
 - a. There was considerable discussion about further liberalization of team eligibility rules (since last September, Division Composites are permitted in Nationals under specific conditions), including allowing multiple teams from the same club. At the same time, the increasing difficulty of holding the growing tournament was pointed out.
 - b. The question of teams of 4 instead of 3 was again raised. Here too, although our internationalists would clearly benefit, the length of team events would increase considerably. In addition, there is the possibility that teams of four would serve to widen the spread between stronger and weaker clubs.
- 2. The need for clearer and more timely dissemination of rules changes to the membership was cited.

3. Directing

- a. The urgent need for developing Class 2 examiners in each section was discussed. As long as examiners must come from a central area, their availability to attend section events will be impaired by time and travel expense considerations.
- b. Should we have a new classification between 2 and 3 so that examiners can award a 2 without concern over having certified a director for use in advanced rounds of the Nationals before that director is fully competent for such levels? It was mentioned that classification alone is not automatic entree to advanced levels of directing; the director must still gradually demonstrate competence in order to gain acceptance by the top fencers as well as the confidence of the Bout Committee; therefore we probably do not need additional layers.

- c. An offer from Canada for reciprocal use of directors in major championships was reported. The US Commission on Fencing Rules and Officials will investigate the idea.
- d. Re-examination of directors was discussed. The FIE has undertaken a project in this area and we plan to follow with one as well.
- e. The membership was informed of new FIE regulations for mandatory supplying of qualified FIE directors by countries entering full teams in major international events, with financial penalties for failure to comply. An attempt will be made to budget for sending officials overseas. f. The suggestion that the National Under-20 (Junior Olympics) be used each year as a Class 2 examination site was referred to the Commission. In view of the development of this event as a true national championships it would appear logical.
- g. Concern was expressed over the very casual dress of our directors at the nationals, particularly in semi-finals and finals when the public is likely to attend. It would seem appropriate in these rounds for officials to be better dressed, particularly when officials are not drawn from among fencers just completing their competition.
- 4. Scheduling of National Championships

There was discussion of the sequence of events as well as the overall scheduling. The sequence is based on many elements of which potential for weapon doubling and availability of strips are probably most important. With regard to the dates, a survey was conducted at the nationals, indicating that an earlier week in June might be appropriate since it would give our internationalists more time before the world championships and might not be inconvenient to too many others.

The Philadelphia Division was thanked for its efforts as host of the 1976 Nationals and for its innovative scheduling.

From The President



By the time this magazine is received, the AFLA national elections will have been officially concluded, national champions will have been crowned, and our fencing team wil have competed in the Olympic Games. For most members of the AFLA it will be the summer "off-season", but for the AFLA administration it will be a very busy period indeed.

In order to start the 1976-1977 fencing season in an orderly manner, essential committee work will be underway during the summer. When the Board of Directors holds its annual meeting on September 18, in addition to making decisions on our budget, we will be appointing working committees and reviewing the Olympic Selection System for the 1980 Games. Both of these topics require extensive preparation and both also provide an opportunity for meaningful participation.

Committees

Each year AFLA appoints many committees at the national, sectional and divisional levels. Appointees are usually persons who have worked in league activities before. Frequently the same people retain positions for years on end while others are critical of what they do or don't do.

Now is the time to step forward as a volunteer in a local activity in which you are interested and have some competence. You will usually find patience with sincere effort. Your experience may result in some errors or omissions at first but your staying on the sidelines may lead to someone less capable or concerned taking on the job instead. Before you ask what your division is doing for you, ask yourself what contribution you are making in time and effort.

At the national level there are fewer committee positions but there is always a need

for new ideas as well as new people. Even if it is not practical for you to be part of a national committee you can submit your views to aid in developing new programs or procedures or improving existing ones. If you can serve on national committees please let me know.

Olympic Selection System

The point system used for the selection of the 1975 Pan American and 1976 Olympic teams has met with widespread approval. I have heard very few suggestions that the basic principles of the system should be significantly changed. Even if the current system is continued substantially as is, however, there are a series of difficult policy decisions to be made and in the context of past deficiencies in communication to our members, the need is for prompt, clear, and complete resolution of issues and announcement of guidelines.


Among the items to be considered by a special committee during the summer are:

- 1. Weighting of 1976 Nationals performance and points earned previously in reconstituting the International Squad. The present squad members must be recognized for prior achievements but promising newcomers must have a reasonable way to enter the squad without long delays.
- Selection of team for 1977 World Championships and other non-Olympic competitions to which we send an official team.
- 3. Scheduling of squad tryouts. In the selection cycle that just ended we received substantial funds for athletes travel to tryouts, particularly in 1975 and 1976. Although continuity of these special events would do much to maintain squad cohesiveness and training momentum it may be impractical from

a travel expense standpoint during the first two years of the new cycle.

- 4. Earning of bonus points at International Events. The system should be reviewed with regard to events (e.g. Pan American Games were not included) and levels of achievement (World Championships quarter-finalists were not rewarded) as well as relationship of potential bonus points compared to basic points.
- Size of squad. Flexibility, room for personal injury cases, etc. must be balanced against practical aspects of travel to and holding of tryouts.
- 6. Personal injury appeals. A filing deadline is needed.
- 7. Ineligibility of Committee. The current policy of the committee that members would not be eligible for Pan Am or Olympic cadre appointments has been a hallmark of the 1972-1976 committee. It has not only reassured fencers of the committee's impartiality but has also earned our sport considerable respect among the governing bodies of other sports. Since it is a policy however, it is appropriate to review it at this time along with our other policies.

Before undertaking the office of President I would like to publicly express my admiration of Steve Sobel for his handling of the job for the past four years and to state my intention to move forward from the strong foundation he has laid for the future progress of the AFLA. If all of our members work for the betterment of fencing in this country there is much we can accomplish. Let this be an occasion for all AFLA members to renew their commitment to our sport.

SHIBBOLETH by Edward F. Lucia

When I was a young student of fencing there were two slogans that were accepted as "Gospel Truth" in the World of American Fencing -

- 1. An effective fencing coach had to be trained in Europe.
- 2. The President of the AFLA had to be an Olympian.

The first Shibboleth has been decently interred for quite some time in all the record books, including the U.S.O.C.

The second Shibboleth has been holding its own and indeed, in the last election for the Presidency, was in rare form.

One day at the termination of practice at City College, the team gathered and auestioned me:

"Coach, there is an AFLA election in the near future and there is a candidate named Steve Sobel whom we know as having directed some of our matches but who has no international competitive experience. We understand that you were his coach; can you explain this? How can the President of the AFLA not be an Olympian?"

"Gentlemen, Steve Sobel was my pupil for many years and has become my dear friend. He was most impressive in Prep School. In his senior year, despite a serious disability, he was the undefeated High School champion demonstrating outstanding character, powers of analysis and great intelligence - all this at the age of seventeen."

"He continued to study with me during his college years, became the nemesis of CCNY, and in his senior year won that rare double sabre individual championship: the IFA and the NCAA."

"Since he is one of those very rare pupils who can learn a new action on Friday and win with it on Saturday, he was obviously Olympic material."

My students quietly but thoughtfully departed.

I should now like to continue this biography for the sake of the record.

Steve continued to study fencing but in a more restrained manner. He had come to the Crossroads: Law School or -? His family being the 'salt of the earth," he decided for the Law and the raising of a charming family. His daughter carries on the fencing tradition.

Steve entered competition and won medals, but now he was in great demand as an official during the major competitions. His great integrity and knowledge of the game, his legal mind and his quiet manner soon solved the thorniest problems. All this under the great pressure of fencers, captains, coaches, audience, "e tutti quanti," This combination was of vital importance for his future. He became involved in AFLA matters, served on committees and was well liked for his courtesy and consider-

Election time came and Steve was asked to run. He quietly agreed.

Shibboleth! Shibboleth! "No international experience etc. etc."

Steve quietly campaigned on the issues - and won.

Of course there was much turmoil all over the country at this time. It was a Pan American and Olympic period. Fencers were concerned over status, money, etc. Steve now had to pick up the pieces and make it all work. With the help of committees and friends and with the excellent liaison at Olympic House - things happened.

A U.S. Olympic Fencing Committee was formed and many hours of constructive debate resulted in an excellent point system.

For the first time in the history of the Pan Am Games, we received more financial support — three coaches and an excellent cadre were selected.

At one of the first Olympic Trials it gave me exquisite pleasure to inform a malcontent that it was now time to "fence" with blade.

Pan Am is history. An Olympic cadre was now elected. Because of excellent relations with the U.S.O.C. we received more training money, again an unprecedented three coaches and alternates and the same Captain, Keane, Manager, Dr. Valsamis, and Armorer, Du Chaine. A Triumph.

Thus, after four years of unremitting labor and a most understanding wife, Steve Sobel has been appointed to a most prestigious international committee and thus a brilliant future continues to unfold.

The 1976 Mid-Atlantic sectional championships, hosted by the Maryland Division and held at the Baltimore Civic Center on May 1-2, had a little something for everybody. The men's foil event was Group I all the way with 3 A's and 2 B's in the final and featured the 1976 US National foil team champions Freeman, Donofrio and Kestler. Epee saw US National champion Scott Bozek get knocked out in the semifinal. The sabre was also Group I with the Philadelphia Division trio of Todd Makler, Maxwell and Ivey in a 3-way fenceoff for the title and featured a surprise finalist in the Maryland Division's Paul Friedberg, a high school junior. The women's foil final. again Group I, was an all-New Jersey Division affair but unfortunately was marred by two of the finalists who indulged in childish temper tantrums, obscene gestures at the officials, baiting the director, and in sulting the spectators, all of which did nothing whatsoever for the fencing. One finalist was expelled from the tournament, but the damage had been done and a bad taste left in everyone's mouth. To his credit, the director kept the situation under control; it is, however, an unfortunate reflection upon the temper of our times that this type of behavior occurs even in a sport which puts a premium upon courteous behavior.

The latest news from the FIE on regulations concerning the equipment comes from the May 1976 Congress, where a number of things were enacted that will affect us all, sooner or later.

First some good news. The color of your fencing glove and of the mesh of your mask is optional with you. That's official. I suppose that as long as nobody abuses the privilege and shows up with psychedelic horrors we can all go on using our brown or tan or black gloves and our steel gray masks. Hooray.

Sabre fencers can take heart for a while again: the FIE has decided that off-target touches must be registered by any electrical scoring system for sabre, so all the people working on sabre machines have been sent back to their drawing boards. On the other hand, sabre fencers do have something new to cope with: blade flexibility. I've remarked before on the lack of precise definition in this area (all that Article 406 has ever said was "Blades that are too stiff or too whippy are prohibited . . ."). Now we have a definition and a measuring system. From now on, sabre blades will have to pass a flex test similar to that used for foil and epee: the blade will be fastened, curve angling down, in a vise at 70 centimeters from the tip, and the same 200-gram weight used for the other weapons will be hooked onto the end, one centimeter from the tip. The bend of the blade will then be measured in the same fashion shown in the foil and epee diagrams in the rule book (pages 35 and 46): the extent of that bend must fall between 7 and 12 centimeters.

Over the last dozen years or so, the general introduction of solid-state scoring machines has brought some problems for manufacturers and fencers alike. One such prob-

lem is derived from the inherent speed of reaction of transistors, SCR's, IC's and so forth. Unless the design has allowed for the imperfections of the associated equipment (i.e., the reels and the fencer's body cord and weapon), the machine may produce foil off-target touches in disgusting excess (I mean when there's no point contact) or spurious epee touches on a guard, even when the grounding path is pretty much as envisioned in the rules. In other words, designers have to work to slow down their solid-state beauties. Some new technical specifications on timing and resistance have been adopted for the future in the hope of preventing these irritating (and often intermittent) phenomena.

At least one other addition will eventually be showing up on new foil machines, perhaps within a year, although its requirement for FIE competitions won't come into effect until January 1978, according to the report of the May 1976 Congress. This new advance is to be a pair of yellow lamps, one to a side, added to show if a contact has occurred between the blade or guard and the lame jacket on the same side. As that grounds out the target and make you invulnerable, it is prohibited. Evidently some of the boys and girls in Europe are being naughty again, especially at close quarters where the director cannot always be sure, at some angles, of what has occurred. The yellow lamp on the naughty side will light and stay lit until reset, showing the no-no, and allowing the director to apply the penalties (Article 230 and 648/b).

Yet another worry for the FIE inspectors: those of you who use metal or molded handles may want to take a closer look at what you're using and look again at Article 25, paragraph 6, which has just had some teeth added by another of the FIE decisions. If more than one position is merely possible for the hand, the handle will be refused at inspection. I should think that handles with minimal "pronging" would be the targets of this purge. Be guided accordingly.

Perhaps the biggest news is the rigorous inspection of masks that is now being car-

ried out. A spring-loaded punch with a tapered point is inserted into the mesh and the spring released. The spring has a force of 8 K.G. (17 pounds). If the punch penetrated beyond the taper, thus opening the mesh. the mask, even if brand new, is declared defective — and at FIE competitions, will be destroyed. Our junior fencers in Poznan recently lost two masks this way. (They knock'em flat, like a pancake. I wonder if a small hydraulic press or just a blacksmith's anvil and a 20-pound sledgehammer will be standard equipment for inspectors from now on? Of course, one could always jump up and down on a mask with one's feet, but that way has no class, no class at

Seriously now, have you looked carefully at your mask lately? And if not, why not?

ATHLETIC DUELLING RETURNS TO OLD SWORD PLAY

Are you bored with foil, epee, or sabre? Tired of being warned for parrying with the unarmed hand? Do you think that an extra dagger in the back pocket would come in handy in your Corps a Corps? Maybe Athletic Duelling is the sport for you.

Developed by Duelling Master Emil Stanlev St. Pellicer, of St. Louis, Missouri, Athletic Duelling is a modern sport based upon old time sword play. Until now, rapier and dagger, sword and shield, small sword, and other styles of fence were limited to theatrical shows or to exhibitions. As a young French actor, Emil St. Pellicer learned these different styles of fencing, with all their authentic movements, but was unable to use these techniques in competitive fencing. Not wanting to lose these exciting and interesting methods, over a period of years he studied and developed the school of Athletic Duelling, which he now teaches in his Salle d'Armes in St. Louis. In order to better establish the new sport in 1971 he organized the American Athletic Duelling Association, which is now presided over by Mr. John H. Culling. The association has developed rules for athletic duelling and is now preparing an Athletic Duelling Code booklet.

Athletic duelling takes its ground rules from those of other combat sports such as Karate, Judo, and Boxing, where combatants can circle each other and use other lateral maneuvers. Japanese fencing, Kendo, still uses such a wide terrain. The weapons used are Rapier and Dagger, Sword and Shield, Small Sword, and Duelling Epee, Duelling Sabre, and Baton. Some of the weapons have been electrified and matches may be held for one point, five points, or more. Provisions in the rules have also been made for multiple affairs, the so called "duelling doubles". In the seventeenth century it was not uncommon for duellists' buddies to team up on the other opponents and have

a small battle. Anyone who has seen films like the Three Musketeers would have observed an example of this type of melee.

The athletic duelling area is a circular ground with a diameter marking off the two sides to be occupied by the combatants. The combat is presided over by a referee, just as in fencing. There is no right-of-way, just as there would not be in a real duel.
